

CDP registration form for self-selected companies

This form is for organizations wanting to disclose to CDP that have not received an official request for disclosure. Please complete the information for all fields below and submit the form to us via the [Help Center](#). Invitations to new disclosers are sent from early April, at which time you will receive an email with registration instructions. Please note, you will need to submit the full version of the questionnaire by the deadline in order to be [scored](#).

There is an [administrative fee](#) that applies to companies responding to one or more of our investor requests on climate change, water or forests. This includes self-selected organizations - those that have not been requested to respond to an investor request, but have chosen to do so independently, irrespective of any supply chain requests. There are [two levels of fee](#), payable once annually regardless of how many programs (climate change, water and forests) a company responds to. The fee applies to all companies excluding those listed, incorporated or headquartered in one of the following countries: Albania, Belarus, Bulgaria, Croatia, the Czech Republic, Estonia, Hungary, Latvia, Lithuania, Poland, Romania, Russia, the Slovak Republic, Slovenia and Ukraine. Disclosers whose company is headquartered outside of North America, Europe, the UK, South Korea, Southeast Asia, Australia, and New Zealand may be eligible for an essential level fee. We may introduce the administrative fee in the exempt countries in the future as reporting becomes standard business practice.
