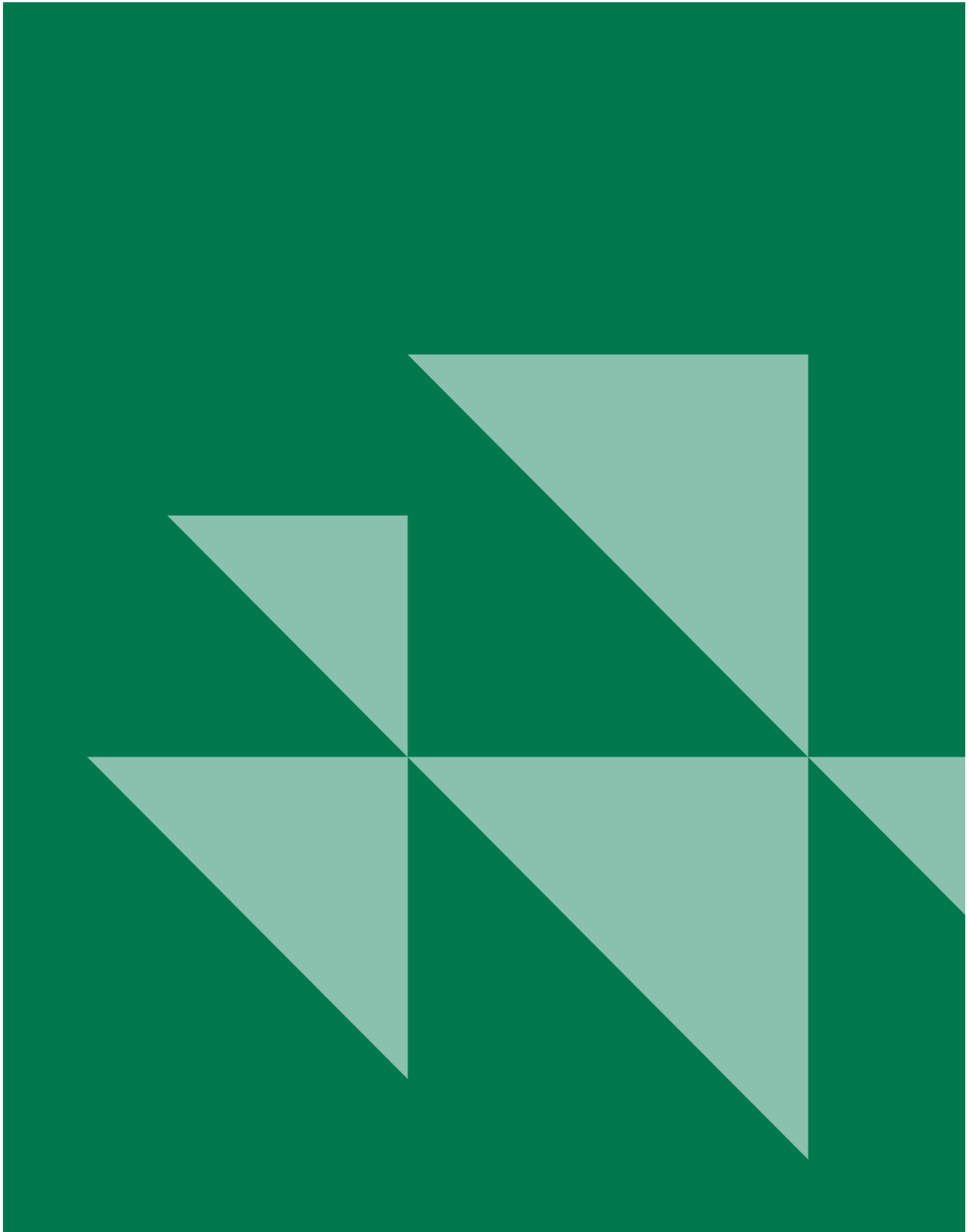

## CDP Scoring Methodology Changes: 2022 to 2023

# 1. Introduction

---

Developments to our questionnaires and scoring methodologies reflect and drive best practice and improve both data quality and the disclosure experience. In line with CDP's 2021-2025 strategy, developments in the 2023 scoring methodology reflect CDP's strategic priorities to track organizations' transition to align with a 1.5 degree, nature-positive world.

This document aims to indicate where the way questions are scored in the 2023 Forests methodology differs from how they were scored in 2022, and where new questions have been introduced and are being scored. Some questions have modified scoring as a result of the question being modified in 2023, and it is noted where this is the case.
