



Scoring:

a measure of a company's environmental performance

Scoring at CDP is mission-driven, focusing on CDP's principles and values for a sustainable economy and as such scores are a tool to communicate the progress companies have made in addressing environmental issues, and highlighting where risks may be unmanaged.

CDP has developed an intuitive approach to presenting scores that highlight a company's progress towards leadership using a 4 step approach: **Disclosure** which measures the completeness of the company's response; **Awareness** which intends to measure

the extent to which the company has assessed environmental issues, risks and impacts in relation to its business; **Management** which is a measure of the extent to which the company has implemented actions, policies and strategies to address environmental issues;

and **Leadership** which looks for particular steps a company has taken which represent best practice in the field of environmental management.


CDP's 2018 questionnaires take a sector focused approach, under this new approach, each of CDP's questionnaires has general questions alongside sectorspecific question aimed at high impact sectors.

The scoring methodology clearly outlines how many points are allocated for each question and at the end of scoring, the number of points a company has been awarded per level is divided by the maximum number that could have been awarded. The fraction is then converted to a percentage by multiplying by 100.

In order to better focus on key data points and provide a more detailed breakdown of a company's score, each question falls into a scoring category. Different weightings will be applied amongst sector scoring categories, and the number of points achieved per scoring category are used to calculate the final score for Management and Leadership levels, according the scoring category weighting.

A minimum score and/or the presence of a minimum number of indicators on one level will be required in order to be assessed on the next level. If the minimum score threshold is not achieved, the company will not be scored on the next level. The final letter grade is awarded based on the score obtained in the highest achieved level. For example, Company X achieved 88% in Disclosure level, 82% in Awareness and 65% in Management will receive a B. If a company obtains less than 44% in its highest achieved level (with the exception of Leadership), its letter score will have a minus. For example, Company Y achieved 81% in Disclosure level and 42% in Awareness level resulting in a C-.

They are also expected to disclose more infomation on water security to meet investors' information needs.

This year marks the eighth year of CDP Water Security for Japanese companies. In 2021, CDP Water Security questionnaire was sent to 361 Japanese companies who were selected based on market capitalization and sectors' impact on water; a total of 223 companies (62%) responded, not including the companies whose parent company responded on their behalf. An additional six companies voluntarily provided responses to CDP Water Security questionnaire. This report outlines the results of the analysis of information provided by the 229 companies, including voluntary responses from these six companies.

Key Findings

Response rate of Japanese companies

Of the 361 companies invited to respond, 223 (62%) responded. The response rate has been steadly increasing year-on-year but issues emerge if we take a closer look at the response rates by sector. For example, Power generation and Apparel are generally considered to be two of the sectors that are most exposed to water risks, but the response rates of these sectors are 40% and 25%, respectively, which are significantly below the overall response rate. Given that the information needs of investors are expected to be higher for these sectors, companies in these sectors should be encouranged to respond so that the information needs of investors are met.

▼Engagement with value-chain partners

Of those Japanese companies that recognize the importance of water availability for indirect use, 83% engage with their value-chain partners, such as suppliers, on water-related issues. Despite the differences between sectors, the proportion of respondents that engage with value-chain partners has been consistently increasing from 76% in 2019 to 82% in 2020. This would presumably be due to the growing awareness of the importance of water risk management in the supply-chain.

Awareness of water risks and opportunities

76% of respondents identify "water-related risks with the potential to have a substantive impact on business" either in direct operations, in value chains, or in both, based on the results of water risk assessment. This is a 3-point increase from the previous year. The proportion of respondents that are aware of water-related opportunities also increased three percentage points to 81%. The proportion of respondents who recognize water-related risks and opportunities has been continuously increasing. Not a few companies may have realized the risk of flooding in the future through climate scenario analysis.

In response to water risks identified in direct operations, many companies have adopted water efficiency processes, such as reuse, recycling, and conservation practices, or have developed flood emergency plans. Conversely, supplier diversification and the amending of business continuity plans are commonly reported as primary responses to risks in value chains.

▼Governance and strategies

83% of respondents have a documented water policy that is publicly available and 91% report that there is board-level oversight of issues related to water usage within the company. Both rates have been increasing continuously for the past 2 years. Furthermore, 48% of respondents replied that their mainstream financial report includes water-related information, which increased by 10 points from the previous year.

■Quantitative targets and qualitative goals

177 companies (77%) set both quantitative targets and qualitative goals, while only 15 companies (7%) have set neither. Most companies have quantitative targets concerning water use.


Conclusion

With an increase in water-related crises, such as droughts and floods in recent years, the total annual cost of damages worldwide is projected to soar. Furthermore, population growth, economic growth, and changes in consumer tastes and consumption patterns are expected to boost the demand for freshwater resources worldwide in future, while there is a concern that shifting rainfall patterns and glacier retreat due to climate change will reduce freshwater availability in some parts of the world. Institutional investors are ever more interested in identifying the sectors that are more prone to water risks; how those companies recognize water risks; and how water-related risks could affect companies' financial position and performance.

This survey shows that Japanese companies' awareness and management level of water risk overall has been continuously increasing. The steady rise in response rate and the sheer number of Japanese companies in the A-List would suggest that companies are trying to recognize water-related risks and opportunities to proactivly counter them. However, there are several sectors that do not sufficiently meet investors' information needs.

Companies will be expected to prepare for water risks that are intensifying as well as maximize water-related opportunities, by redoubling their efforts in in-depth assessment of water risks in the value chain, target setting considering properties of the watershed in which a company site is located,

engagement with value-chain partners, the use of internal pricing on water, and contribution to solving water-related social challenges through products and services. They are also expected to disclose more information on water security to meet investors' information needs.
