### "Getting started" (March – May)

#### 1. Gap analysis

#### 2. Kick-off workshop with tips & tricks

In a workshop, we elaborate practical tips and tricks together with your team to complete your response in an efficient and successful way: How should the questionnaire be completed in order to gain a maximum of points? How to get through the process most efficiently?

#### 3. Verification of your carbon footprint
